

Shuttle service provided by Dev Rendler and his nephews brought people down to the oak shaded site where Ethel Worn and Stefanie Singer greeted them. Attendees were invited to view the one room schoolhouse and the grounds where children once laughed and played.

A delicious basket lunch was served on the deck overlooking the creek. This was followed by dessert platters beautifully arranged by Frances Dietz and Beez Jones. Michelle Potts made sure there was plenty of Picchetti Chardonnay available. All of this led up to the informative presentation by Linda Sharman Schultz who spoke on the history of the San Antonio School and the efforts to preserve the building and the site. It had been in her family's keeping for many years. Now it will be on display at the museum with the original school desk.

Lyddon (deceased), and engaged in parenting, wifery and community activism until moving to California in and community activism until moving to California in the early 70's to pursue her deepening commitments to the environment and human potential fields. Her impassioned intellect led her to absorb, through experience and the writtern word, everything she could about the world around her. PRESIDENT'S MESSAGE Charles Newman, President

The Snyder-Hammond house and its historic 1 acre site was acquired by grant deed on 10-11-00 as a gift from the Diocese of San Jose for the consideration of \$1. Tim and Laura Summers are continuing their occupancy as caretakers for the Society under an agreement for one year. The O'Brien Group, developer of the nearby Oak Valley residential development, has committed \$25,000 to preserve and renovate the house. The Society has made application to the County Historical Heritage Commission for a \$50,000 grant to do needed foundation and structural work. The Society will actively participate with the Council and interested groups for the planning of the expansion of the Rancho San Antonio park. The house is adjacent to the planned trail connecting to the historical De Anza Knoll and other regional trails.

Steve Haze has returned to the Board to fill the vacancy from the resignation of John Kolski. Welcome back Steve. Thanks John for your service to the Society.

Don Allen is again Chairperson of our Annual Fund Drive now in progress. DIRECTOR'S REPORT Ethel Worn, Director

SYMANTEC. Corporation FUNDS EDUCATIONAL OUTREACH BROCHURE

In late September 2000, the Symantec Corporation Giving Program awarded the Cupertino Historical Society and Museum one thousand-dollars. These funds, with a five hundred-dollar grant received from the Sourisseau Academy in June, will defray the costs of publishing and printing a brochure familiarizing teachers and administrators with the educational outreach program of the Cupertino Historical Museum. The brochure will help the museum continue to build partnerships with the local school district to insure that the history of Cupertino stays alive for all to understand and share.

The Traveling Trunk shares the story of life in Cupertino through memorabilia from horseshoes to high button shoes. Many objects teach students about the history of schools in Cupertino and encourage them to draw comparisions between early schooling and their present school experiences. Managed by dedicated docents, the program regularly makes its way into the community.



MUSEUM FULLY STAFFED

I am pleased to report that as of the first of December, the Museum is fully staffed. We hired a volunteer coordinator, Layla Mary Tawil, in September and in November I contracted with Corinna Schoenfelder, our registrar, to work as parttime office manager.

Our three part-time employees work 48 hours a week. With these people on board, the museum will now be able to accomplish many of its goals.


